Further to our acknowledgement, we can confirm that Oxford City Council can advise as follows in response to your Freedom of Information Request received on 23 October:

This FOI is for the attention of the council officers who oversees the selective licensing scheme which started on 1st September 2022.

- 1) How many property inspections has the council undertaken of selective licenced properties? Please provide this information for each year since the start of the scheme and, if possible, for each ward in the designation till the end of August 2024.
- 2) The number of properties, in the selective licenced area, with category one hazards that have been identified. Please provide this information for each year since the start of the scheme and, if possible, for each ward in the designation till the end of August 2024.
- 3) The number of properties, in the selective licenced area, with category two hazards that have been identified. Please provide this information for each year since the start of the scheme and, if possible, for each ward in the designation till the end of August 2024.
- 4) How many licences have been granted since the scheme began? Please provide this information if it is possible, for each ward in the designation till the end of August 2024.

Response

1) How many property inspections has the council undertaken of selective licenced properties? Please provide this information for each year since the start of the scheme and, if possible, for each ward in the designation till the end of August 2024.

Unfortunately, we are unable to provide the data at ward within 18 hours allocated to a request due to the way the data is recorded on our systems and therefore we believe that to provide this level of detail would exceed the appropriate limit set out in section 12 of the Freedom of Information Act 2000 and the Fees Provisions. The appropriate limit is defined as £450 for Oxford City Councils set out at an arbitrary rate of £25 per hour and 18 hours of compliance with an individual request. We believe that there are approximately 478 records, and that it would take approximately 10minutes to log into each case to retrieve and record the data. Accordingly, we confidently estimate that it would take at least 80 hours to undertake such a manual trawl and, therefore, we believe that using a section 12 exemption to not undertake this trawl is appropriate.

Pleaser be advised as per Section 16 of FOIA that we are waiting on a supplier upgrade and will be able to provide this information in near future.

Data is stored in Metastreet or the Council's UNIFORM database, any other administrative data is stored in protected shared folders (documents and spreadsheets)

We have interpreted this question as "How many unlicensed selective licensing properties have the council identified during the Selective Licensing scheme till the end of August 2024?"

We have received 165 reports of unlicensed selective licenced properties, of which 80 made applications, 45 were closed as not licensable and 40 are still under investigation.

Please note - this is where reports were categorised as unlicensed Selective Licence properties

and not HMOs. Should you wish for data regarding HMO licensing and reports of unlicensed HMOs then please make a follow up request.

12) The number of properties in the licensing scheme which have been identified as having both category one and category two hazards present till the end of August 2024.
